Office Order.

Sub: Guidelines for implementing the revision of rates of stipend to post institutional trainees of CIFNET-Reg.

Ref: 1) Ministry's letter No. 15035/5/1991-Fy(T-5) dated 17-06-2019

2) This office letter No. 1-21/2010-Trg. Dated 25-07-2019.

Vide the letters referred above, the Stipend of the Post Institutional Trainees has been implemented with effect from 01-07-2019. The following guidelines are to be implemented for engagement of the post institutional trainees/casual hands against the regular Junior Deckhand in order to curtail over expenses and to regulate the posting of the post institutional trainees.

1. The status-co of post institutional trainees of Junior Deckhand, Tenure and ERAs are as follows;

S.No.	Vessels	Post institutional Trainees	Regular Junior Deckhand	Regular Senior Deckhand.
a)	M.V. Prashikshani	5 Jr.Deckhand (Tenure) + 4 ERA	4	4
b)	M.V. Skipper-II	5 Jr.Deckhand (Tenure) + 4 ERA	2	3
c)	M.V. Tharangini	5 Jr.Deckhand (Tenure) + 4 ERA	2	2

2. The post institutional trainees shall be posted by H.Qtrs. as per the position indicated above, which need to be strictly ensured and their payment/stipend will be @ Rs.20,500/- per month after submission of revised bond.
3. In case of vacancy of the tenure hands, the same may temporarily filled by engaging the passed out students who may be paid proportionately as per the stipend allowed. No candidates who has denied the post institutional trainees offered earlier should be considered for casual posting.
4. The vacancy against the regular post of Junior Deckhand or Senior Deckhand may be filled by casual posting through the CIFNET candidates who already completed the post institutional trainees or with the local fishermen, but not exceeding 3 fishermen at any particular time, in order to carryout effective fishing effort.
5. The payment for the casuals against the post of Junior Deckhand and Senior Deckhand may be paid as per the minimum pay scale of the post.
6. In case of exigency, if any CIFNET candidates without post institutional trainees posted against the regular vacancy of Junior Deckhand/Senior Deckhand may be paid only the proportionate amount of the stipend.
7. The uniform as required has to be worn strictly by the post institutional trainees and failure to follow the uniform guidelines will be viewed seriously and uniform allowance will be recovered accordingly, if required.

8. The posting of any of the causal hands against post institutional trainees tenure/Junior Deckhand regular need to be prior declaration of number of days of experience acquired in a prescribed format as follows;

The above declaration are true to the best of my knowledge and in case of found wrong at any stage, I shall be liable for any action deemed fit.

Signature of the Candidate.

The above instructions are to be strictly followed and complied with. The Operation section shall scrutinize the details furnished by the Skipper thoroughly and forward the same for payment with due certificates. The attendance sheet for all the post institutional trainees/casuals engaged against the tenure shall be separately furnished for payment of stipend /proportionate amount of stipend.

Sir,

It is to inform that the stipend of post institutional trainees of CIFNET has been revised/enhanced w.e.f 01.07.2019 as shown below vide Ministry's letter cited above

Sl No	Post	Period of Training	Stipend per month
1	Jr.Deckhand/Jr.Deckhand cum Greaser /Engine Room Assistant	9 months sea service for Deck side and 270 propulsion days for engine side	Rs.20,500/-
2	Apprentice Fitter	6 months in work shop	Rs.9500/-
3	One time uniform allowance	Per trainee	Rs 2500/-

As the uniform allowance is being paid to the post institutional trainees, it may please be ensured that the trainees are wearing proper uniform with black shoes and socks during their duty hour as follows.

- a) App.Fitter/ERA - Dark blue boiler suit b) Jr.D/H - Navy blue boiler suit

Accordingly it is also proposed to revise the surety amount of Jr.Deckhand/Jr.Deckhand cum Greaser/Engine Room Assistant as Rs.61,500/- (3 X 20500), and that of Apprentice Fitter Rs.28,500/- as shown below: The revised stipend may be paid only after obtaining the revised surety bond, for which the revised format is enclosed herewith.

Sl No	Post	Existing Amount	Revised Amount
1	Jr.Deckhand/Jr.Deckhand cum Greaser /Engine Room Assistant	Rs. 48,000/-	Rs.61,500/-
2	Apprentice Fitter	Rs.18,000/-	Rs.28,500/-

Further, if any casual posting is engaged against Post Institutional Trainees, they may be paid only the proportionate amount of the stipend. No casual hands against the tenure posts like ERA/Dr. Deckhands will be paid the payment of the incumbent against regular vacancy, if any. However, experienced casual hands engaged against regular posts like Jr. Deckhands/ Sr. Deckhands may be paid as per the scale of respective posts. You are, therefore, requested to take necessary action as per the revised structure.
